2. The Main objects of the Trust are:

  - II. To run dispensaries and hospitals for the benefit of the poor and needy
  - III. To donate for the marriage of poor and needy girls and to Contribute for the purchase of articles or things for the purpose of the marriage.

3. It is hereby clarified that none of the above objects are intended for the benefit of any particular religious or other community as such. It is further clarified that the objects of the Trust shall be carried out only in India - It is further clarified that the objects of the Trust will not be carried on with any intention to make profit, and that the Trust will not carry on any business.



4. The above objects shall be independent of each other and the Trustees hereinafter may from time to time apply the surplus fund of the Trust for carrying out one or more objects of the Trust.
5. The following persons shall be the Trustees of the Trust, and shall hold office for life from the date of formation of this Trust and shall not be removed from such office except for breach of Trust or misconduct.




6. In addition to above, the Trustees may appoint from time to time one or more persons as Trustees to hold office for such period as may be determined at the time of appointment.
7. In case of any vacancy in the office of any Trustee, arises either due to death or otherwise, another Trustee shall be co-opted by the existing trustees.
8. Shri Jai Kumar Jain shall be the Managing Trustee of the Trust, and during his absence Shri. Naveen Jain shall act as Managing Trustee.
9. The Managing Trustee shall, subject to the general directions of the Trustees, have all the powers of Management and administration of the Trust, including powers to appoint, dispense with or terminate the services of employees, professional advisors and other retainers & investments of the Trust Fund & properties in the manner suited to the objectives of the Trust and shall sign all documents for & on behalf of the Trust.
10. The Managing Trustee shall preside over all the meetings of the Trustees and he shall have a second or casting vote, in the event wherein votes are even.
11. The Trustees may meet together for the dispatch of the business of the Trust as & when they think fit. The trustees shall have the power to regulate their proceedings, including determination of quorum reqd. for the meeting
12. A Minute book shall be regularly maintained for the resolutions passed at the meetings of the Trustees or by circulation.
13. The Trustees shall have full powers over the management of the Trust and properties & funds of the Trust and they shall likewise be entitled to take all steps as may be reasonable or required for the preservation of the Trust properties and the title of the Trust to the Trust properties.

14. The Trustees together shall constitute the Board of Trustees.
15. The Board of Trustees may frame rules and bye-laws to administer the Trust so as to effectuate the objects of the Trust aforementioned. The Trustees from time to time at their discretion constitute such committee as they think fit to assist them in administration of the objects of the Trust and such committee or Committees may consist of one or more of the trustees and such members of the public as are nominated by the Board of Trustees from time to time.
16. Trustees shall have the power to receive and to accept contributions in money or property or in kind by way of addition to the Trust Fund generally or for anyone or more of the specified objects of the trust and such contribution shall be dealt with either as capital or as income according to the directions of donor at the time of gift, donations or contributions and the Trustees shall do all things as may be necessary to act up to the wishes of such donor.
17. The funds of the Trust are as under :
  - i. The initial contribution of Rs.10,001/-.
  - ii. Any income from the initial contribution .
  - iii. Any other contribution that may be received by the Trust from time to time.
18. The funds of the Trust are hereby vested with the Trustees of the Trust.
19. The funds of the Trust may be invested in Nationalised Bank by way of Deposits, Government Bonds, other manner as may be permitted by the provisions of the section 11 (5) read with section 13 10(d) the Income Tax Act, 1961.
20. Proper accounts shall be kept for the funds, properties and income of the Trust which shall be audited by a Chartered Accountant from time to time. The

Trustees are authorized to acquire both movable and immovable properties for the objects of the Trust and similarly the Trustees have the right and authority to sell, lease, mortgage or otherwise transfer or otherwise deal with such movable or immovable properties for the objects of the Trust.


21. The Trustees are authorized to open account or accounts in any one or more Banks which may be operated by the Trustees, jointly or severally or as may be authorized by the Board of Trustees from time to time
22. The Board of Trustees are empowered to borrow monies for the objects and purposes of the Trust from Banks, Financial Institutions and others with or without security and for that purpose to enter into any agreement, deed, document and also to offer as security any of the movable or immovable properties of the trust.
23. In case of any doubt in the interpretation of the objects of the Trust, or the Trust Deed, the interpretation placed by the Board of Trustees shall be binding on all persons.
24. It is hereby declared that any amendment to the object of the Trust or the deed of Trust shall be made effective only after approval thereof is obtained from the concerned Commissioner of Income Tax/ Director of Income Tax (Exemption) as the case may be.
25. The Trustees shall have the power from time to time and at any time to call in or otherwise dispense of the trust properties and realize all or any of the securities, investments & assets and reinvest or utilize the same in such manner as may be deemed fit by them how-ever subject to statutory provisions. All investments and documents of title shall be made & taken in the name of the Trust only.

26. The funds and income of the Trust shall be solely utilized for the objects of the Trust and no part of the income or funds of the Trust shall be utilized for payment to the Trustees or members by way of profit, interest, dividend etc.,
27. In case the Trust is to be wound up, the funds of the Trust shall not in any way be returned to the settlor or to the Trustees but shall be transferred to another Trust having more or less similar objects.
28. The activities of the Trust shall be confined within India.
29. If there is any difference of opinion regarding any matter relating to the Trust the majority view will prevail.
30. This Trust is irrevocable
31. At present the Trust has no immovable properties.
